INTRODUCTION

The word ecology was derived from the Greek roots oikos meaning 'house'. Ecology is literally the study of "homes" or environment. Ecology is defined as the study of the interrelationships between organisms and their environment, including all biotic and abiotic components¹. The term was first used in 1866 by Ernst Haeckel a German biologist. In its recent usage, ecology is generally taken to mean the study of the structure and function of nature. Thus, its core themes in modern usage include: the relationship between habitat stability, rate and direction of evolution, and changes in biodiversity; the relationship between environmental changes caused by human activities and by extinction; the importance of diversity as an attribute of ecosystems and of the biosphere, and the significance of losses of diversity; carrying capacity and the extent to which useful productivity can be enhanced and sustained; and resilience, the extent to which nature can restore itself².

In simple terms, ecology is the study of interactions between living organisms and their environment, and the pattern of distribution of plants and animals on the earth³. Since a human being is also a living organism, the study of his environment (surroundings) is also a part of ecology. The study of ecology is becoming more and more important, as human beings are modifying the environment surrounding them, through their activities and actions⁴. Ecology helps us to understand our environment, and the changes that are likely to take place in it due to any kind of actions that we undertake. Ecology also proves helpful in day to day planning for economic and sustainable development. Ecological harmony was a guiding principle basic to the Greek's understanding of nature. They believed in the order, harmony and balance of the universe. There is a purpose for everything.
