Professor Christine Kilpatrick appointed as Commission Chair

The Australian Commission on Safety and Quality in Health Care (the Commission) welcomes the appointment of Professor Christine Kilpatrick AO as the Commission's new Board Chair for a five-year term.

Minister for Health and Aged Care, the Hon Mark Butler MP, confirmed Professor Kilpatrick's appointment as Commission Chair, effective 1 April 2024. The Commission leads and coordinates safety and quality improvements across the Australian healthcare system.

Christine has served as a non-executive member of the Commission's Board since July 2023. She has a distinguished career, including healthcare management experience spanning 20 years as a senior executive including 15 years as a chief executive, most recently at The Royal Melbourne Hospital.

Prior to these executive appointments, Christine was a neurologist specialising in epilepsy, working in both public and private practice.

Professor Kilpatrick is also a board member of Healthdirect Australia and the Florty. She has previously served on the board of HealthShare Victoria, the Victorian Comprehensive Cancer Centre (VCCC) Alliance and as Chair of the Doherty Institute and the Victorian Quality Council (VQC). She is an Enterprise Professor at the Faculty of Medicine, Dentistry and Health Sciences, University of Melbourne.

A highly respected health leader, Professor Kilpatrick was awarded a Centenary Medal in 2001, was appointed an Officer of the Order of Australia in 2019 and was recipient of the Distinguished Fellow's Award, Royal Australian College of Medical Administrators in 2017.

The Commission's CEO, Conjoint Professor Anne Duggan, paid tribute to outgoing Chair, Professor Vitis Marshall AC, who was first appointed to the role of Board Chair in 2013.

"Professor Vitis Marshall has made a significant contribution during a remarkable period of change in the healthcare sector. Under his leadership, the Commission worked with Professor Marshall to deliver system-wide improvements in safety and quality standards, medication safety, healthcare variation and infection control, among other achievements.

"Professor Marshall leaves an incredible legacy at the Commission, as he hands the baton to incoming Chair Professor Kilpatrick to continue to drive meaningful and transformative improvements to the safety and quality of health care."

Professor Duggan added: "The Commission is delighted to welcome Professor Kilpatrick as Chair, as we turn our focus to priorities such as clinical governance, reducing low value care and improving sustainability within the healthcare system.

Health Committee, 2008 The Government is committed to involving Parliament in the appointment of key public officials and nominees for certain positions should be subject to a pre appointment hearing with the relevant select committee The hearing would be non binding but in the light of the report from the committee Ministers would decide whether to proceed On 30 April 2008 the Secretary of State invited the Health Committee to hold a pre appointment hearing in respect of Baroness Young of Old Scone the candidate for Chair of the Care Quality Commission CQC The Report looks first at the CQC and the role of the Chair then at the appointment process and finally considers the suitability of the candidate The Committee finds that Baroness Young is a suitable candidate for the post and has the requisite professional competence independence and integrity

Appointment of the Chair of the Care Quality Commission Great Britain. Parliament. House of Commons. Health Committee, Great Britain. Parliament House of Commons, 2010-09-15 On July 20 2010 the Secretary of State for Health informed the Health Committee that the Government proposed to appoint Dame Jo Williams as chair of the Care Quality Commission The Committee held a pre appointment hearing on 9 September and endorse Dame Jo Williams candidacy for the post The Committee also stated its concurrence with Dame Jo that although the CQC has made encouraging progress a substantial number issues remain Some of the key points forward included the need to establish a clear understanding of the distinctive roles of the chair chief executive and management the need to develop a common CQC culture the need to develop clear internal cost and efficiency targets and reporting procedures and practical challenges arising from the merger

Annual accountability hearing with the Care Quality Commission Great Britain: Parliament: House of Commons: Health Committee, 2011-09-14 Following its annual review of the work of the Care Quality Commission CQC the Health Committee reports that the bias of the work in the CQC away from its core function of inspection and towards the essentially administrative task of registration represents a significant distortion of priorities The Committee reports that the CQC was established without sufficiently clear and realistic definition of its priorities and objectives the timescales and resource implications of the functions of the CQC were not properly analysed the registration process itself was not properly tested and proven before it was rolled out the CQC failed to draw the implications of these failures adequately to the attention of ministers Parliament and the public Consequently the Committee welcomes the government's decision to postpone registration of GP practices and recommends that proper planning including piloting of the model for registration should be undertaken before the revised date of April 2013 is confirmed The Committee also welcomes recent announcements that the CQC intends to undertake annual visits of all NHS and social care providers It goes on to stress the importance of the role of inspectors in assessing the culture in care providers especially concerning the obligation which rests on all healthcare professionals to raise concerns if they recognise or ought to have recognised

Health to undertake a performance and capability review which produced a wide range of recommendations The decision by CQC board member Kay Sheldon to give evidence as a whistleblower added to the controversy She identified serious failings within the management organisation functions and culture of the CQC and it is unacceptable that the CQC failed to address and act on them before she felt compelled to approach the public inquiry It is clear from the evidence presented by the CQC's outgoing Chair Jo Williams and recently appointed Chief Executive David Behan that the regulator is aware of the reforms that must be implemented The CQC's primary focus should be on ensuring that the essential standards it enforces can be interpreted by the public as a guarantee of acceptable standards in care The CQC's essential standards in their current form do not succeed in this objective Equally the CQC must be far more diligent in communicating the outcomes of inspections especially to residents in social care and their immediate family In the long term the CQC has a role to play in facilitating a culture of challenge and response across health and social care so that identifying and addressing failings becomes a standard process for staff and management Providers must support staff in raising concerns in order for those staff to meet their own professional duties Those organisations who fail in this obligation should be refused registration by the CQC

House of Commons - Health Committee: Post-Legislative Scrutiny of the Mental Health Act 2007 - HC 584 Great Britain: Parliament: House of Commons: Health Committee, 2013-08-14 According to the Health Committee more needs to be done to protect the interests of patients who rely on mental health services The Committee has undertaken a review of the 2007 Mental Health Act ISBN 9780105412076 Many psychiatric wards are over capacity and there is huge pressure on beds nevertheless the Committee was shocked to learn that there is evidence that patients who need hospital treatment are being sectioned unnecessarily in order to access a bed This represents a serious violation of patient's basic rights and it is never acceptable for patients to be subjected to compulsory detention unless it is clinically necessary The 2007 Act contained important provisions which introduced Community Treatment Orders CTOs These orders allow for patients to be treated in the community whilst still being subject to recall to hospital if their condition deteriorates The Committee is also concerned that pressure on hospital beds may be driving increased use of CTOs MPs also examined the function of Independent Mental Health Advocates who help patients take advantage of their rights whilst in hospital The Committee is in no doubt that a patient's primary advocate should be their clinician and independent advocates ultimately provide an important but supplementary service

House of Commons - Health Committee: 2013 Accountability Hearing with the Nursing and Midwifery Council - HC 699 Great Britain: Parliament: House of Commons: Health Committee, 2013-12-18 In this report the Health Committee welcomes improvements in the performance of the Nursing and Midwifery Council NMC over the last year but expresses continuing concern that the progress made so far remains fragile The Committee emphasises that it is important to ensure that the new challenges facing the NMC do not become a distraction from the continuing requirement to improve its performance of its core functions The report is the first example of a Health Committee review of a professional

regulator which builds on the work of the Professional Standards Authority PSA The length of time the NMC takes to conclude its fitness to practise cases has been an enduring concern for the Committee From 2015 the NMC proposes to toughen the target period for resolving fitness to practise cases to 15 months eventually to 12 months The NMC has announced plans to introduce a system of revalidation by the end of 2015 which is welcomed The Francis Report into the failings at Mid Staffs examined the role of regulators including the NMC in detail The report stresses the importance of ensuring firstly that registrants understand their professional obligation to raise concerns when they see evidence of poor patient care and secondly that patients and public are made more aware of the role of the NMC as the regulator of professional and clinical standards The NMC should take urgent steps to raise the profile of the NMC both among its registrants and among patients and public

HC 401 - Managing the Care of People with Long-Term Conditions Great Britain: Parliament: House of Commons: Health Committee,2014-07-03 15 million NHS patients in England with long term conditions such as diabetes arthritis and asthma account for 70% of the annual expenditure of the NHS in England One projection estimating that the bill for treatment of long term conditions will require the NHS to find 4 billion more each year by 2016 Increasingly patients do not have a single long term condition but live with two or more conditions complicating treatment and adding to its cost The Committee strongly supports the development of individual care planning for people with long term conditions based on the principles successfully demonstrated in the NHS House of Care programme Care planning approaches will involve GPs community health services and specialists sitting down with the patient to draw up a personalised plan for the care required which includes the support needed to help the patient manage his or her own condition The challenge though of introducing personalised care planning for 15 million people is substantial The Committee looked at the prevailing view that services to treat long term conditions should be moved out of hospitals and into primary and community care To provide effective care for these conditions services have to be maintained across all settings from support in the home through to acute specialist care and many conditions will continue to require specialist services delivered in hospital Effective management of long term conditions also requires collaboration with other government providers such as housing and transport services

HC 805 - End of Life Care Great Britain. Parliament. House of Commons. Health Committee,2015 This report looks at the state of end of life care since the independent Review of the Liverpool Care Pathway chaired by Baroness Neuberger It finds great variation in quality and practice across both acute and community settings It makes a number of recommendations for improvement and in particular strongly recommends that social care should be free at the end of life Other conclusions included that all clinicians and providers who may care for people at the end of life should be aware of the Five Priorities of Care but in light of the variation in practice a senior named person in each NHS Trust be given responsibility for monitoring how end of life care is being delivered within their organisation expertise should be more equitably available to people with a non cancer diagnosis older people and those with

dementia all staff who provide palliative and end of life care to people with life limiting conditions should receive training in advance care planning including the different models and forms that are available and their legal status most people who express a preference would like to die at home but that is made more difficult by the shortfall in community nurses and specialist outreach palliative care sustainable long term funding for the hospice sector also needs to be addressed as part of the Government's response to the Palliative Care Funding Review and bereavement support for families should also be consistently included as part of end of life care

House of Commons - Health Committee: 2013 Accountability Hearing with Monitor - HC 841

Great Britain: Parliament: House of Commons: Health Committee, Stephen Dorrell, 2014-03-26 This year's inquiry into the work of Monitor concludes that the model of care provided by the health and care system is not changing quickly enough with the result that pressures continue to build threatening the financial stability of individual providers and therefore the quality of care provided The pressures are likely to be particularly marked in the acute sector as plans are prepared and implemented to achieve the resource transfer required by the introduction of the Better Care Fund from April 2015 Continuing this theme the Committee argues that as the NHS financial situation tightens the challenge for Monitor in supporting trusts in financial difficulty is likely to increase The MPs emphasise the importance of addressing pressures within individual providers in the context of the local health economy The requirement for major change in the care model can only be delivered if individual providers and Monitor as their regulator look beyond preserving existing structures and address the need to develop different structures to meet changing needs The Committee also expresses concern that Monitor has not done enough to reform the system of tariff payments for providers arguing that the current tariff arrangements often create perverse incentives for providers and inhibit necessary service change It recommends that Monitor and NHS England should initiate a formal joint process for a prioritised review of the NHS tariff arrangements with the objective of identifying and eliminating perverse incentives and introducing new tariff structures which incentivise necessary service change

Public Expenditure on Health and Care Services Great Britain: Parliament: House of Commons: Health Committee, 2013-03-19 This report states that the values of the NHS will only be reflected in practice if NHS and social care services are re imagined The care provided by the health and social care system will break down if quicker progress is not made to develop more integrated health and social care services which focus on meeting the needs of individual patients It is unlikely that public expenditure on health and social care services will increase significantly in the foreseeable future This means that the only way to sustain or improve present service levels in the NHS will be to focus on a transformation of care through genuine and sustained service integration There must be a much more joined up approach to commissioning health and care services On other issues the Health Committee also concludes measures currently being used

to respond to the Nicholson Challenge too often represent short term fixes rather than the sustainable long term service transformations changes in tariff payments within the NHS do not constitute efficiency savings they are simply internal transfers under spending against budget of money allocated to the NHS has attracted adverse comment and the MPs call for a general review of the operation of Treasury rules the NHS will not be able to rely on the present rate of paybill savings once the present restraints on public sector pay are relaxed in April 2013

Post-legislative assessment of the Health and Social Care Act 2008 Great Britain: Department of Health,2013-05-20 The 2008 Act falls into five main parts whose main objectives were to establish the Care Quality Commission to change arrangements for regulation of health professionals and of the health and social care workforce to update the Public Health Control of Disease Act 1984 to create the Health in Pregnancy Grant and to make miscellaneous other changes in relation to health and social care Most of the provisions of the Act are now in force in some cases with amendments made by later legislation The main exceptions include part 2 sections 124 126 which dealt with various matters in the remit of the General Social Care Council and were not commenced Instead the Council was abolished and its functions were transferred to the Health and Care Professions Council in 2012 Part 3 provisions relating to port health have not yet been commenced but the intention is that they will come into force at the same time as new port health regulations The Act achieved its objectives or in the case of port health is in the process of doing so with the exception of the creation of the Office of the Health Professions Adjudicator The rest of the memorandum considers each Part of the Act in more detail with information about secondary legislation made under the powers created by the Act and key guidance issued in relation to it any legal issues that have arisen in relation to the Act and other reviews of the Act that the Department of Health is aware of

Draft Care and Support Bill Great Britain: Parliament: Joint Committee on the Draft Care and Support Bill,2013-03-19 The Government has not fully thought through the implications of its social care reforms and may leave local authorities open to a deluge of disputes and legal challenges MPs and Peers warn that without greater integration with health and housing and a focus on prevention and early intervention the care and support system will be unsustainable The Committee also calls for a nationwide campaign to educate people about the need to pay for their own care saying that adult care and support are poorly understood Key recommendations include a new power to mandate joint budgets and commissioning across health care and housing such as support for the frail elderly making it simpler for NHS and local Councils to pool budgets fast tracking of care and support assessments for terminally ill people new legal rights for young carers to protect them from inappropriate caring responsibilities and ensure they get the support they need an obligation on the Secretary of State to take into account the draft Bill s well being principle when designing and setting a national eligibility threshold independent resolution of disputes over decisions about care and support and costs that count towards the cap through a Care and Support Tribunal In addition the Committee makes a number of recommendations to improve health research and the education and training of NHS workers The Committee also warns that restricting support
