United States bankruptcy code chapter 11 generally provides for reorganization for partnership or corporation. As provided for by this chapter, a debtor proposes a strategy or plan for the reorganization to keep business alive as well as pay creditors with time. Individuals and businesses undergoing financial crisis seek relief in chapter 11.

In case a business can no longer service debtors or even pay creditors, the business itself or creditors may file for bankruptcy with the federal court. This is provided for in the Chapter 11 and Chapter 7. In most cases, Chapter 11 allows debtors to maintain control of the operations of the business as the debtors in the possession. However, the business is subjected to court's jurisdiction and oversight.

The United States bankruptcy code chapter 11 retains most features that are present in most or all bankruptcy proceedings. It also provides additional tools that debtors can use as well. The most important aspect of this chapter is that it empowers trustees so that they can operate business of the debtors. According to this chapter, unless a trustee is selected or appointed for the cause, debtor acts as the business trustee as a debtor in the possession.

The debtor in the possession is afforded several mechanisms that they can use in restructuring the business. For instance, the debtor may acquire loans or
