Different patterns of tubulin 3 immunostaining in melanoma were described dermoscopy immunohistochemistry associations were found specific dermoscopic features highlighted and the prognostic value of this tubulin 3 marker was examined The progression rate in patients whose melanomas had areas with loss of tubulin 3 was 4 times higher than in patients without this feature although statistical significance could not be reached $p = 0.06$ In conclusion transcriptomic analysis expanded the set of senescence associated markers that could distinguish nevi from melanoma and identified tubulin 3 as novel immunohistochemistry marker shown to have diagnostic and probably prognostic value From a mechanistical point of view ultraviolet radiation was shown to promote not only the formation of melanoma but also its progression by increasing a cathepsin TGF 1 FAP pathway resulting in extracellular matrix degradation Malignant melanoma is a form of cancer that develops in melanocytes the cells in the skin that produce the pigment melanin and form the majority of the skin's color. Malignant melanoma accounts for 5% of all skin cancers but is the most aggressive and deadly. A common sign of melanoma is a mole that changes in size, shape, or color. Early detection and treatment are crucial for a good outcome. In a study, researchers found that tubulin 3 is a marker for melanoma. They used immunohistochemistry to look at tubulin 3 in melanoma cells and found that it was present in a higher percentage of melanoma cells than in normal skin cells. This suggests that tubulin 3 could be used as a marker to help diagnose melanoma. The study also found that tubulin 3 levels were higher in melanoma cells that had spread to other parts of the body, suggesting that it could also be used as a prognostic marker. The researchers concluded that tubulin 3 is a promising marker for melanoma and that further studies are needed to confirm its usefulness.
