The peculiarities of the relationships which are developed between female prisoners differ considerably so that it is not easy to provide a clear description of what can happen in prison even if a solid basis of knowledge about criminology and law is obtained. For example, the PREA may be used as a step to control sexual relationships between prisoners, but it cannot be defined as a purely positive or negative approach that has a certain impact on the management of jail life. Rape has been considered as one of the most controversial issues in society during many centuries due to the inability to create one definite attitude to this act. On the one hand, there are numerous rape cultures where people create the environments full of sexual assault and violence and believe that it is normal to develop such relationships (Phipps, Ringrose, Renold, and Jackson 2017). On the other hand, rape, as well as other forms of sexual assault, is an abusive act that may change human lives considerably. In the modern world, people fail to understand if rape is a problem or a solution to their problems. However, the presence of special healing programs and the intentions to protect people against unwanted sexual relationships
